- 1. Participant agrees to follow all applicable Saturday Farmers Market vendor rules (attached separately).
- 2. Participant will **not charge the Department nor the Public** for presentations nor exhibitions (including musical entertainment). The only monetary exchange will be for individual sales of products/goods. Any cost incurred for booth utilization will be solely that of the PARTICIPANT. No payments or reimbursements will be made.
- 3. Participant will be responsible for ensuring facilities <u>remain clean and in working order during utilization</u>. Market staff will confirm upon conclusion of use.

 Negligence will be noted and prevent future participation.
- 4. Participant will be respectful to all VIDA staff, vendors, patrons, and visitors during their time at the VIDA Fairgrounds. All public engagement will be courteous and/or professional. Should any conflict arise, Participant will seek Market Management assistance immediately.
- 5. Participant will only present and/or sale material and products submitted to VIDA Market Management prior to exhibition. No additional presentations and/or products will be allowed.
- 6. Participants may **not** present/sale on behalf of additional entities other than listed on the application form.
- 7. Participant will submit a list to VIDA Market Management prior to the exhibition, of all members who will be on-site during the exhibition. This will include the number of vehicles that may need vendor parking passes (allotted as available not guaranteed to be provided).
